If a branch is not convenient, post your application along with proof of income and a certified copy of two forms of ID for both Principal Applicant and Additional Applicant to ANZ Credit Card Application, FreePost 92659, Private Bag 39802, Wellington Mail Centre, Wellington. If posting, a Justice of the Peace or Solicitor will need to sign, date and place a daytime contact phone number on a copy of each piece of identification submitted.
